I have, at my request, been permitted by the proprietors, staff, instructors, employees and agents of Canberra Indoor Rock Climbing (all jointly and severally referred to as "CIRC") to engage in the sport of rock climbing at the premises of CIRC being 38-40 Essington Street, Mitchell, ACT (the premises).
2. In consideration of being so permitted, I give this release and indemnity.
3. I am aware that any climbing by its very nature has an element of danger and unpredictability in its practice, and serious or permanent injury or death could possibly result to me from my participation in it.
4. I am aware the sport has safety procedures, practices and rules that must be understood and observed at all times. I represent that I am familiar with such procedures, practices and rules and that I participate in the sport of my own free will without any inducement or coercion by any other person.
5. I agree to follow all safety procedures, practices and rules applicable to the sport, and I acknowledge that CIRC has relied on this release and indemnity, and the representations made herein, as an essential condition in determining to permit me to participate.
6. I agree that my participation in the sport at 'the premise' is at my own risk. To the full extent permitted by law I release CIRC from all claims and demands of every kind and from all liability which may arise in respect of death of or injury to any person or myself, and any damage to property whatsoever kind or nature arising from participation in rock climbing at 'the premise'
7. I hereby indemnify CIRC and hold CIRC indemnified against any liability described above.
8. In entering into this agreement, I have relied on my own advice, and have not relied on any oral, written or visual representations or statements by CIRC. This agreement shall be binding on my executors, administrators and assigns, and shall be governed by and interpreted in accordance with the laws of the Australian Capital Territory.
9. I agree that this release and indemnity is a continuing agreement and will apply to all future participation by me in the sport at the premises.
